

Gratitude for 110 Years of Progressive Leadership



The end-of-year holidays and the celebration of National University's 110th anniversary have come and gone. Another year has begun and I find myself reflecting

on all of life's provisions that have been afforded me and am thankful for all the blessings I have received. There is also good evidence that demonstrates that those who express gratitude, will experience less depression and increased life satisfaction.

I was reminded of one particular spirit of gratitude last fall. I was returning home on 1-65 on a beautiful Sunday after a weekend of continuing education in Indianapolis, Indiana. Traffic was light during the drive as I was listening to the radio broadcast of the Bears trying to play football. About an hour into my trip, the sudden slow down of vehicles brought my attention quickly to the sea of brake lights in front of me. The flow of traffic moved over to the right at a snail's pace as I approached the cause of the slowdown to see a car flipped on to its roof in the grassy median. As my vehicle approached, I saw a man sitting a few yards beyond the vehicle being attended to by motorists exiting their cars from the southbound lanes.

I pulled over toward the median and quickly retrieved my sideline bag from my trunk and began walking to this man that needed help. He was sitting up and communicating appropriately with a large contusion of his left eye, and had a towel wrapped around his left elbow. I introduced myself and reassured him that he was going to be well taken care of and I would do everything I could for him until EMS arrived. With ABCs intact and a GCS of 15, I began my primary and secondary surveys. I worked to address his wound on his left elbow as the sirens started multiplying and getting louder. He had a degloving injury to the skin overlying the lateral epicondyle and extensor origin. I gloved up and debrided the wound of the embedded grass. Upon questioning him, he said it was a consequence of crawling out of his upside down vehicle (wear your seatbelt!). Thankfully a couple of sterile 4x4s and some gauze was all he needed until EMS arrived.

During that one minute wait, which seemed like 20, he began thanking me for my help and wanted my contact information so that he could "properly" thank me. I declined and told him that completing his impending rehabilitation as directed by his physicians and therapists would be thanks enough. EMS arrived and I updated the paramedic about what I did and my findings. She thanked me and repeated the primary and secondary surveys before getting him up onto a gurney and into the ambulance. Once in the rig, he once again began petitioning me for my contact information but only more vehemently. I reluctantly wrote down my cellular number for him and wished him well before returning to my vehicle.

As I was putting my sideline bag into my trunk an Indiana State Patrolman

came up to me and shook my hand with a sincere thank you. I replied, "You're welcome, but I didn't do much." He said that I did more than I'll ever know and wished me well.

A few days later this motorist texted me a heartfelt thank you with a picture of himself after a skin graft surgery. There was no nerve damage or fractures and his eye contusion had resolved nicely. I was happy to hear that he was on the mend and didn't expect to hear from him again until he sent a thank you card in the mail the following week. He was very gracious and expressed his gratitude to me for "saving his arm"; again just two 4x4s and some gauze.

This entire experience reminded me how thankful I am to have attended a university that through 110 years of progressive leadership has created a curriculum that has allowed me to serve mankind in many different ways. The skills that I learned from my Emergency Procedures class have served me well many times throughout my career. I'm thankful that NUHS continues to create a culture of academic integrity, clinical mastery, and professional leadership so that all of its alumni are able to serve wherever they are needed.

Esse Quam Videri – National's Beacon



When John Fitz Alan Howard, DC, established his chiropractic school, the National School of Chiropractic and Institute of Adjustment, in Davenport, Iowa, in December 1906, he also created a motto for that school, Esse Quam Videri, "to be rather than to seem to be." Dedicated to this "National Beacon," he moved his school to Chicago in 1908 to reap the benefits of a greater scientific and healing arts center for his students.

Committed "to be rather than to seem to be," Howard himself enrolled in Rush College of Medicine to further his own education and become John Fitz Alan Howard, DC, MD. At Rush, he also taught botanical medicine, and there met his successor, William Charles Schulze, MD. Schulze, like his mentor and friend, also committed to the National motto and earned a second medical degree of his own, from National School of Chiropractic to become William Charles Schulze, MD, DC.

When he assumed the presidency in late 1919, Dr. Schulze changed the name of the institution to "The National College of Chiropractic," and was totally dedicated to excellence in education, especially at a time when the allopathic medical profession was trying its best to stop the progress of the chiropractic profession by instigating the use of "basic science examinations" prior to licensure, assuming that chiropractic students could never pass the examinations. Some in the chiropractic profession worked to undo the legislated mandate for basic science examinations. Dr. Schulze, on the other hand, true to the National motto, stated emphatically: "The way to deal with the basic science examinations is to study basic sciences, and to study basic sciences, and to study basic sciences!"

Dr. Schulze would have been proud to know the continued commitment to National's motto was carried on by his successor, Joseph Janse, DC, ND, DDT (doctor of drugless therapy), who was named National's president in 1945. By the late 1960s, Dr. Janse would mandate institutional and programmatic accreditation something that was not part of the chiropractic educational scene. When I was a young faculty member in 1972, and we were working toward recognition by the New York Board of Regents, I heard Dr. Janse say, "I will close the doors of this institution before I will give up the effort to obtain accreditation!" Esse Quam Videri!

During my presidency, our institutional beacon led the way as we mandated the baccalaureate for entrance into the doctoral degrees, and as we expanded from a single purpose institution into a multi-purpose university. It was this very motto that promoted us to think in terms of "collegiality rather than competitiveness" in the field of complementary and integrative medicine. It is what caused us to think in terms of putting different healing arts doctoral and master's degrees in the same college so that students and faculty could study and learn together, and begin the process of understanding and developing inter-professional collegiality instead of continuing the century long struggle caused by the competitive nature of the allopathic profession toward any other healing art profession.

Esse Quam Videri has continued to guide President Joseph Stiefel, MS, EdD, DC, since he assumed the mantle of the presidency in June 2013. Even his educational background, which includes the Master of Science, the Doctor of Chiropractic, and the Doctor of Education, reflects a commitment to serve this expanding university in a way never previously seen. Dr. Stiefel brings not only the professional understanding to the position, but also the very significant value of a doctoral degree in education, which allows him to become the bridge between various educational programs and further the concept of "collegiality rather than competitiveness."

It is now 110 years of commitment to an institutional motto that has been reflected by the university's presidents, faculty, staff, administration, and board of trustees. This is what sets National University apart. This is why National University is known the world over as the institution of excellence in education. It has been my very great pleasure and privilege to be part of this institutional history since 1964 when I first enrolled.

Leadership In Sports Medicine

Dr. Carlo Guadagno – 2016 Sports Chiropractor of the Year

As a leader in international and national chiropractic sports medicine, NUHS faculty member Carlo Guadagno, DC, CCSP®, ICCSP, FICC, has traveled all over the world treating some of the best athletes. For these efforts, the American Chiropractic Association Sports Council (ACASC) named him 2016 Sports Chiropractor of the Year.

He received the recognition in October at the council's symposium in New Orleans. When presenting the award, the selection committee, which is made up of previous winners, cited Dr. Guadagno's international work treating various types of athletes including USA track and field, pro beach volleyball and D1 college football. This award is the council's highest honor nationwide that is given on an annual basis. In 2011, Dr. Guadagno was also named Sports Chiropractor of the Year by the FCA Sports Injuries Council.

"The award came as a surprise," Dr. Guadagno said. "It was quite an honor to be selected from among many of my distinguished peers."

About a month prior to receiving the award, Dr. Guadagno fulfilled his career-long dream of treating Olympic athletes at the 2016 Olympic Games in Rio de Janiero. Chosen from hundreds of applicants, Dr. Guadagno was part of an international team of just 16 DCs who were placed in the Olympic Village Polyclinic.

"It is the highest level of sport, and thus it was quite an honor to be part of the sports medicine staff," he said.

Throughout his 28-year career, Dr. Guadagno has been working toward the goal by treating athletes at Olympic training centers, including the U.S. training facilities in Chula Vista, Colorado Springs, and Lake Placid, and at several International Olympic Committee events such as the 20th and 22nd Central American Games in Cartagena, Colombia, and Veracruz, Mexico, as well as the 2011 Panamerican Games in Guadalajara, Mexico. The Olympic Village Polyclinic has only recently included DCs on its team, making the inclusion of the 7 multinational chiropractors an historical event. During the games, Dr. Guadagno provided treatment to all athletes requesting services, from any country's team in any sport.

"This honor shows just how dedicated he is to the field of sports chiropractic. One of the reasons NUHS can offer such a high standard of learning to its students is because of great instructors like Dr. Guadagno."

"NUHS is proud to have a top practitioner like Dr. Guadagno be part of our university," said Daniel Strauss, DC, dean of the College of Professional Studies in Florida, where Dr. Gaudagno teaches. "This honor shows just how dedicated he is to the field of sports chiropractic. One of the reasons NUHS can offer such a high standard of learning to its students is because of great instructors like Dr. Guadagno."

Dr. Guadagno is also an active member of ACA, which he currently serves as a delegate for Florida. He previously served as a past president of the Council on Sports Injuries, Rehabilitation and Physical Fitness of the FCA and on the board of directors of the ACA Sports Injury Council.

He is already preparing applications for more international sports games, including the World Games in Poland next year and the next Summer Olympics in Japan in 2020.

NUHS Journals – A Leader In Research and Innovation


Throughout its 110-year history, the National University of Health Sciences has been a leader in chiropractic research and innovation, particularly for the last four decades through its publication of three premier scientific journals.



In 1978, the University published the first scientific journal in the chiropractic field to be included in Medline:

The Journal of Manipulative and Physiological Therapeutics (JMPT). This journal is widely considered the chiropractic profession's flagship journal and is currently the only refereed, internationally, and Medline indexed biomedical journal for the chiropractic profession.

In addition to randomized clinical trials and systematic reviews, the JMPT publishes a considerable body of evidence on the scientific basis of mechanisms of manipulation. "Understanding how the manipulation works is extremely important when communicating with other health care professionals, and such research provides the basis for treatment," said Gregory Cramer, DC, PhD, dean of the Department of Research.



National University's *Journal of Chiropractic Humanities* (*JCH*), an annual publication that celebrated its 23rd year in 2016, fosters scholarly debate within the fields of humanities and provides a professional forum for various views. Topics include history, philosophy, linguistics, literature, jurisprudence, ethics, theory, sociology, and aspects of social sciences that address historical or philosophical approaches.

"In order for any profession to grow, scholarly discourse and contemplation is needed to promote critical evaluation of core principles and beliefs," said Claire Johnson, DC, MSEd, PhD, editor-in-chief for the University's journals. "NUHS leads in this domain since no other chiropractic journal is dedicated solely to philosophical discussion that is done in this scholarly, rational, and professional manner."

The *Journal of Chiropractic Medicine* (*JCM*) is in its 16th year of publication and focuses on practical clinical applications. Topics include sports medicine, care of children, chiropractic technique, nutrition, acupuncture, rehabilitation, care of aged patients, diagnostic imaging, public



health issues and many others within the scope of chiropractic and integrative care. Many specialty societies have chosen JCM as their official

scientific journal including the American Chiropractic Board of Sports Physicians, Council on Forensic Sciences, Council on Diagnostic Imaging, International College of Chiropractic Neurology, and ACA Council on Chiropractic Pediatrics.

Today, National University's three journals are more robust than ever. They are included in a multitude of electronic medical and science databases, including PubMed, and contribute substantially to the body of health care research. Their value is even more important in today's changing health care landscape that requires evidence-based substantiation for procedures done in practice.

The highlights of any institution's history are benchmarked through time. In 2016, National celebrated 110 years of excellence. As has been our tradition, June brought alumni back to the halls of the Illinois campus to our annual Homecoming.

While more than a century of graduating health care providers in itself is worth celebrating, the overall feeling of this year's Homecoming was a sentiment greater than calendar years can express. Commemorating 110 years of existence allows for a context by which current and future alumni can come together to not only retell the National story, but to provide an opportunity to reshape and refocus our future. Janse Hall displays a placard that it was built in 1962, but the influences and history are retained not within the bricks and mortar of buildings, but from the people who lectured within its classrooms, from the patients that did as much teaching within its walls

To celebrate the current generation of alumni, the University identified key players in the pursuit of the institution's mission. This was to be the last Homecoming for Dr. Collins, as he retired in 2016 from a long career at NUHS – being first hired in 1986.

In perhaps the purest reflection of the spirit of the University, Dr. Burt Rubin (1978), while being recognized by the Alumni department for his contributions over the years, took time to thank those responsible for his success. In addition to describing the importance of giving back, he talked about the patients he served throughout his career. He spoke about what they had taught him and how proud they made him feel. Dr. Rubin then turned to his long-time office manager, April Allen, and asked her to join him on stage. Having been to every single Homecoming since his graduation, Dr. Rubin had promised April that one-day she would be able to come to Illinois for the event. During her recognition, he attributed his success to her unwavering work ethic.

Dr. Rubin's actions remind us all of the importance of Homecoming. Homecoming provides the opportunity to connect on a more complete and personal level. Whether that connection is with old classmates, faculty members, new students, or retired alumni, Homecoming gives us a platform to express our gratitude to the University community for helping us develop into who we are today.





In this celebration of National University's "110 Years of Leadership," it is also fitting to recognize the 10th anniversary of the institution's degree programs that transformed a 100-year-old single-purpose chiropractic college into a full-fledged university dedicated to integrative medicine.

In September 2006, during National University's centennial year, the Doctor of Naturopathic Medicine, Master of Science in Acupuncture, and Master of Science in Oriental Medicine programs welcomed their first students. At that time, President James Winterstein, DC, now president emeritus, called it "a bold step forward to bring students from several fields of alternative medicine together on one campus."

Fueling the popularity of these programs are National University students who choose to dual enroll in chiropractic, naturopathic or oriental medicine and expand their scope of practice. Distinguished faculty members with outstanding credentials in their fields and proactive student organizations have added to their success.

Zhanxiang Wang, MD (China), PhD, LAc, assistant dean of the Acupuncture and Oriental Medicine program, is proud of the current curriculum's blend of eastern and western medicine, particularly the students' ability to learn about the human body in the gross anatomy laboratory, a rare distinction from other AOM schools. Students appreciate the ability to visualize the needling of acupuncture points to various depths. Dr. Wang also emphasized the excellent experience available to AOM students who are able to intern at John H. Stroger Jr. Hospital of Cook County during the clinical internship phase of their degree program. The clerkship provides real world experience in integrative medicine, the hallmark of a National University education.

In addition, he cited the opportunities that students have to offer services at the Veterans Clinic in the Lombard Whole Health Center and out in the community at events aimed at serving homeless veterans. Interns provide ear seed therapy for veterans, a non-invasive treatment to stimulate key acupuncture points shown to relieve symptoms of post-traumatic stress disorder.

Looking forward, Dr. Wang reports, the AOM department will continue to expand its research efforts in acupuncture and integrative medicine, invite more visiting scholars in different styles of AOM, as well as explore opportunities for students with Asian universities. Currently, details are being finalized for a group of AOM senior students and recent graduates to participate in a pilot program in Beijing, China, in May 2017, and report back on their experiences and the feasibility of developing the program further.

The Naturopathic Medicine Program achieved another milestone this year, earning re-accreditation for a six-year period from the Council on Naturopathic Medicine Education (CNME), the longest period of accreditation the program has ever received. Dr. Fraser Smith, who helped launch the program 10 years ago and serves as its assistant dean, says, "We are on the threshold of new growth and many new achievements in teaching, patient care, scholarship, and research in the next 10 years." Dr. Smith specifically noted the new naturopathic hydrotherapy lab in the Lombard clinic. "The new facility not only speaks to our commitment to provide excellence in clinical education, but also shows the growth and expansion of the ND program."

In achieving re-accreditation, CNME positively cited an engaged faculty as one of the program's strengths. This engaged ND faculty along with NUHS students and administrators have made the pursuit of licensure for naturopathic medicine in Illinois a top legislative priority.

Over the past year, National University has welcomed more than 20 key legislators to the Lombard campus for personalized tours highlighting the ND program. "After legislators visit campus, they are really quite enthusiastic about supporting us," says Dr. Kristina Conner, chair of clinical sciences at NUHS and the current president of the Illinois Association of Naturopathic Physicians (ILANP). "Our most recent group of co-sponsors signed onto the bill as a result of their visit."

On a national level, seven NUHS students attended the American Association of Naturopathic Physicians (AANP) Federal Legislative Initiative in May in Washington, D.C. along with Ron Mensching, NUHS vice president for business services. They met with Illinois Congressman Danny Davis and a legislative staffer for Illinois Congressman Peter Roskam.

Statewide, NUHS President Joseph Stiefel joined faculty, students, and alumni at the ILANP Lobby Day in Springfield in May. The group made 60 visits to legislators and their staffers supporting ND licensure. This commitment of the university to advancing the naturopathic profession earned the institution the President's Award at ILANP's 4th annual conference in October.

Senator Iris Martinez, chair of the Illinois Senate Licensed Activities and Pensions Committee, is the lead sponsor of the state senate bill that would license naturopathic physicians in Illinois. Co-sponsors include Senators Toi Hutchison, Thomas Cullerton, and Michael Noland. The lead sponsors of an identical house bill are Representatives Robyn Gabel and Arthur Turner, with co-sponsors Rep. Sheri Jesiel and Rep. Stephanie Kifowit.

National University Continues To Focus On Veterans



National University continues to demonstrate its commitment to supporting veterans. In addition to participating in the Yellow Ribbon program for veteran education, the University offers free and discounted acupuncture and other health services at our on-campus Veterans Clinic in the NUHS Whole Health Center, through a generous sponsorship by the China-Gel Corporation. Veterans can also receive massage sessions from student interns at lower prices than private practices.

Faculty member Jerrilyn Cambron, DC, MPH, PhD, LMT, recently moderated a panel about massage in the military during the American Massage Therapy Association (AMTA) Convention in October. The panel discussed the benefits massage can provide to veterans.

A big health concern for many veterans is post-traumatic stress disorder (PTSD). Triggered by experiencing or seeing a terrifying event, the health condition can last months or years and result in a variety of symptoms including flashbacks, emotional numbing and anxiety.

According to Dr. Cambron, a few research studies indicate that massage therapy may be beneficial for the treatment of PTSD, particularly in veterans. "Other studies demonstrating positive benefits have focused on massage therapy for anxiety and for pain, both of which are associated with PTSD," she said.

Veterans aren't like every other massage client, however. During the panel, Dr. Cambron and other experts discussed that veterans may have different needs, especially those with PTSD. For example, they may have an aversion to touch on certain parts of their body or they may be uncomfortable lying in a dark room with their face down.

"It is important for massage therapists to discuss certain needs with their clients who are veterans," Cambron said.

NUHS is committed to supporting faculty who are keeping abreast of special population needs, such as U.S. veterans.




